Ms. Kirk Fair began her career at Analysis Group in 1996, and returned to the firm after completing her M.B.A. in finance and applied economics at the MIT Sloan School of Management. She has participated in multiple litigations on behalf of MasterCard International, and in the presentation of trial testimony in several large litigations involving alleged anticompetitive practices by Microsoft.
